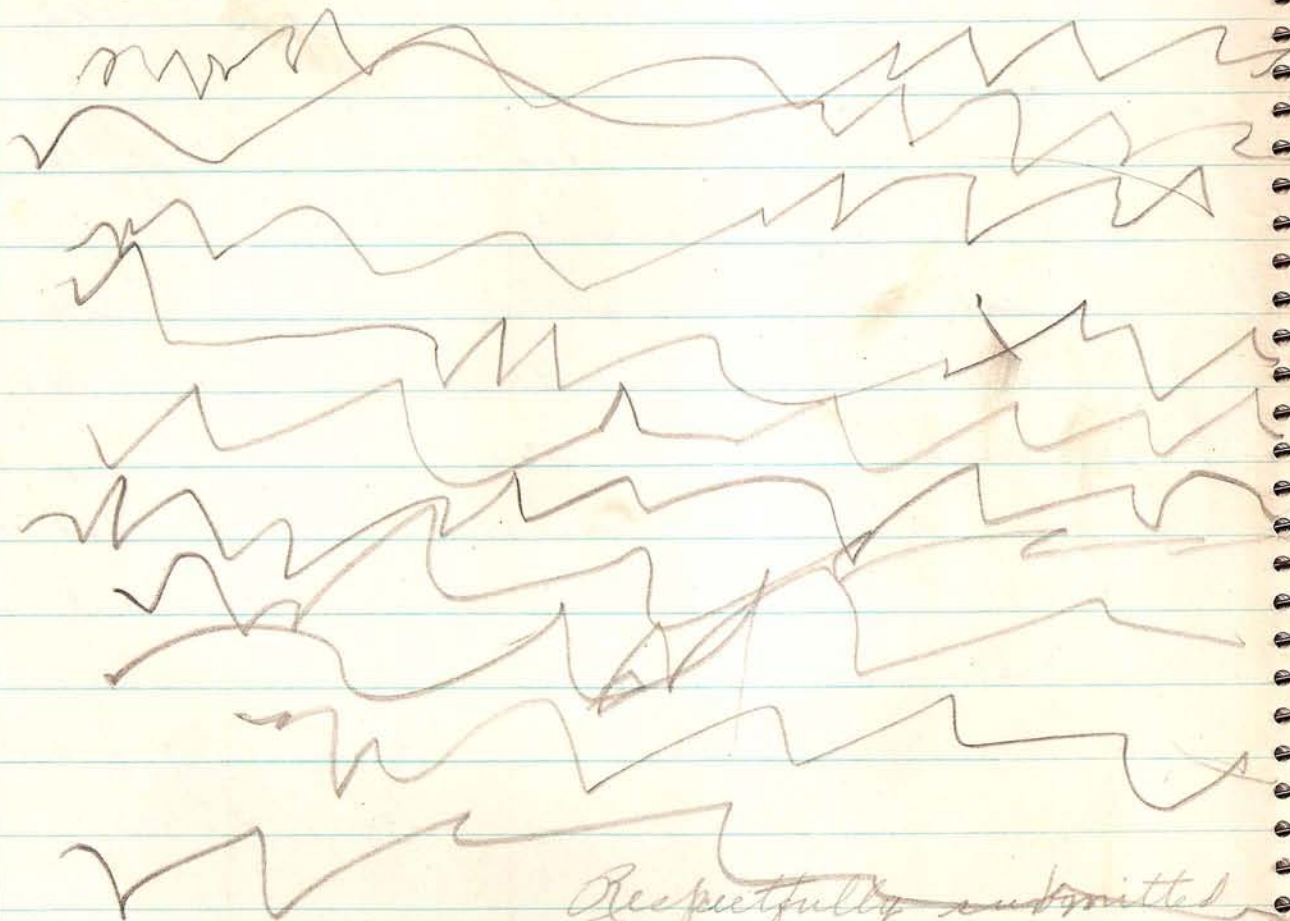

The regular meeting of the Thinner's Class met at the home of Mr. and Mrs. Bernard Nelson on December 19, 1942.

The meeting was called to order by the president and the minutes of the previous meeting were read and approved.

Virginia Nelson was elected as the new secretary.

There was no other business and the hostess took charge of the entertainment. At the close of the evening gifts were exchanged.
